### MINUTES of the ANNUAL VESTRY MEETING and PAROCHIAL CHURCH MEETINGS

### for Bickleigh and Shaugh Prior, held on Tuesday May24th at 7.30 pm live at St. Anne's church and on Zoom

Chairman: Fr. Simon Rundell Present: 24 parishioners (list in file)

Following a service of Evening Prayer and refreshments, Fr. Simon welcomed everyone present at the APCM whether in person or on Zoom. He advised those attending online that, on the Archdeacon's instructions, they were allowed to speak and stand for election, but not to vote.

**Apologies** had been received from Sandy Anderson, Jo and Chris Carpenter, Ulla Ellis, Frank Hartkopf and Paul Vann.

Annual Vestry Meeting for the Election of Churchwardens for the Parish of Shaugh Prior Paul Vann was willing to stand again and was duly elected nem. con. A vacancy still exists for a second Churchwarden. Fr. Simon paid great tribute to Paul for all his work over the past year.

#### Annual Vestry Meeting for the Election of Churchwardens for the Parish of Bickleigh

Andy Collins and Ruth Smales had both tendered their resignations. Fr. Simon thanked them both for their work over the past year – though Andy's had necessarily had to be in the background due to his illness. Grace Hooper made a presentation on behalf of the Parish to Ruth in person, and Andy *in absentia*. Fr. Simon will deliver the card and gift to Andy. **Rob Clark**, having been proposed by Janet Liddicoat and seconded by Ruth Smales, was duly elected nem. con. as Churchwarden for St. Anne's.

Fr. Simon expressed his deep disappointment and concern that no-one had been prepared to take on the position of Churchwarden for St. Mary's. This puts St. Mary's in a difficult position. The Archdeacon will be invited to attend our next PCC meeting to speak about the pastoral reorganisation that will be required. Possibility that St. Mary's may be made redundant, or that Shaugh Prior and Bickleigh will be merged into one parish – which would be detrimental to **all** our churches.

Fr. Simon said he was very grateful to Rob for standing as CW for St. Anne's and is sure we will all support him. He paid tribute to Ruth for all her hard work, her commitment and her faith.

### Annual Parochial Church Meeting held on May 24<sup>th</sup> 2022

- **Reports** (see filed with these Minutes) Fr. Simon ran through his report:
- This has been the 10<sup>th</sup> year of Fr. Simon's incumbency. Attendance has been very much down because of the pandemic. And Fr. Simon's ill health due to diabetes, two seizures while in hospital, and consequent depression, caused him to miss both Christmas and Easter. He thanked clergy who had helped out over this period of his absence. (For full details see report.) He was sorry to report at we have lost 4 parishioners over the past year: Mrs. Margery Tomlin, Mrs. Audrey Barry, Mr. Ron Boyd and Mr. John Cains.
- Electoral Roll: Janet Liddicoat has now taken over the responsibility for this, with technical assistance as required from Fr. Simon.
- PCC: Fr. Simon reminded the meeting that, although the term of office once elected to the PCC is normally 3 years, it had been decided (by the PCC) several years ago that a

continuous term of office would be acceptable. He thanked the members of the PCC for their service over the past year.

- Financial: Fr. Simon thanked both the Treasurers for their sterling work in collating the accounts for the year. Our finances have suffered, of course, due to the pandemic; but Shaugh Prior have managed to pay their Common Fund in full this year. Mark observed that his written report was missing from the papers not known quite how that happened. Fr Simon will publish it via the weekly newsletter.
- Deanery Synod: no meetings had been held.
- Others: as per filed.
- Fr Simon thanked everyone for their reports, and Janet for her music ministry since the resignation of Sarah, our organist at Bickleigh, at Easter; and said that he and all of us would continue to prayerfully support Andy.

Fr. Simon has started "More Tea, Vicar" sessions on Wednesday afternoons, inviting anyone who wishes to come along to the Vicarage between 2 and 4 pm for tea/coffee/cake/ a chat/fellowship. He also made the point that PCC meetings in the future will not be held on a Tuesday, as that is his day off. He hardly took a day off at all during lockdown, and thought that this fact was probably responsible for his subsequent illness.

He hopes to run the original intended Lent Course, **Living in Love and Faith**, in which several people had expressed an interest, at a suitable time and place in the future.

# Vicar's Report of the Year 2022-2023

## Background

The PCCs of the parishes of Bickleigh and Shaugh Prior which comprise the **Roborough Team Ministry** have the responsibility of co-operating with the Priest-in Charge, the Revd Simon Rundell in promoting in the ecclesiastical parish the whole mission of the Church: pastoral, evangelistic, social and ecumenical. It also has the responsibility for the maintenance of the Grade I listed Church buildings of S. Mary the Virgin, Bickleigh, S. The Parish also has a duty of care to the community which usually meets in the Church of England VA School, Bickleigh Down Primary School as the Church of S. Cecilia.

### JOINT PCC

The Two PCCs continue to meet in a single meeting. Matters of common interest are discussed jointly. Matters of finance or fabric are voted on by the separate PCCs according to need. This has proved effective in improving the connection between both legal parishes.

Both Parochial Church Councils (PCCs) continue to be charities excepted from registration with the Charity Commission. As their individual incomes (receipts) do not exceed  $\pm 100,000$ . Each PCC has produced its own Financial Statement.

For the purposes of charity law the Council of PCC members is also the Board of Trustees of the charity.

## **Review of the Year**

This is the eleventh full year of Fr. Simon's incumbency in the Roborough Team Ministry. Worship has returned to three of our Churches after COVID, but with some compromises as numbers have never been smaller. **S. Cecilia's** is certainly unsustainable at present and hasn't met since lockdown. **S. Anne's** and **S. Mary's** still have not recovered in number, so it has been a successful comprise to alternate Parish Worship between the two churches. **S. Edward's** is continuing to operate steadily. There has been a rise in the number of families coming for baptism and a few more weddings are in the diary over the next couple of years.

### **Electoral Roll**

This information is now collated by Fr Simon and Janet Liddicoat on a database in accordance with GDPR guidelines. This data is a subset of data collected by permission of individuals which record pastoral encounters, visits, contact information and other details necessary to ensure that the people of our Parishes are effectively cared for.

This ER notes the number of people who remain on the electoral roll and yet are not regular attendees of Church. This is an explanation as to why numbers on the ER are not reflected in the Average Sunday Attendance (ASA) Data from which our Parish Share is calculated.

Since the previous APCM in May 2022, we note with sadness the passing of **Miss Shirley Hill, Mr** Gerald McMullin, Dr Cam Wilson, Mr Frank Clements, and Mr John McIver, Reader.

May they rest in peace And rise in glory This has been a year of, for me, unremitting sadness and loss. My mental health has suffered greatly in the past couple of years which has had a direct impact on the success and growth of the Parish. This was expressed in a very difficult Parish meeting in July 2022 where my style of liturgy was heavily criticised after more than 11 years in this form.

The intervention of the former Archdeacon to remove me from the Church of England School in our midst, to which I had given my heart and soul to, was a devastating blow from which I still have not recovered. We now have no clergy link with the School. Bickleigh Down School was the most visible and effective part of my ministry and is no more. I place my trust in the remaining Foundation Governors, so they will be able to ensure the school retains its distinctive Christian ethos and maintains its recently awarded **excellent** judgement at the SIAMS<sup>1</sup> Inspection. I pray also for reconciliation.

Attempts to make the administration of the Parish easier had not been fulfilled, and the desperately needed administrator for the Parish could not, in the current financial situation be funded. The 'More Tea, Vicar?' initiative started well, but fizzled out due to lack of interest.

After the initiative of **Frank Hartkopf** we reinstituted a food bank out of S. Anne's, which ran with a moderate degree of success, but after numerous structural and organisation changes from our partners, the **Devon and Cornwall Food Action**, often at very short notice, it was clear that our vision for the provision of free/very cheap food was at odds with their 'business model' and scale of charges. We decided therefore as a parish to discontinue our association with them, yet are still on the lookout for a suitable opportunity to serve the community in this way.

Many members of the Parish have been hugely supportive, loving and encouraging. I would like to commend particularly, **Diane LeGrys**, **Janet Liddicoat** and **Wendy Round** for their work and ministry in the Parish and in their support and where needed, gentle correction of me. I would also like to thank **John Baddeley** for picking up the reigns as Parish Treasurer.

#### Good Evening,

I can confirm that I have completed my independent examination of the St Edwards Church, Shaugh Prior's accounts. I can confirm that no material matters have come to my attention during my examination that give any cause for concern.

I do however note a couple of minor points around the records held to enable ease of identification for future examinations:

- All receipts must be kept including for all reimbursements (x1 receipt missing for PV)
- Invoices that are not yet addressed to St Edwards need to be changed to reflect this. This to ensure there is no confusion around the charges and who they relate to.
- Costs payable to the organist, verger and casual duty should be documented fully.

# **Churchwarden's Report: Shaugh Prior**

Following the major disruption to services and attendance as a result of Covid in 2021, I am pleased to report that some semblance of normality returned to St Edwards in 2022 with regular services being held throughout the year, alternating weekly between a Eucharist service and Morning Prayer. I am proud to say that a service was held at the church 50 weeks out of a possible 52 thanks to the loyalty, dedication and continued faith of a "hardcore" of parishioners. This loyalty has enabled the church to continue to function as a place of worship, peace and prayer, being "open" 24/7 throughout the year. The fabric of the building was maintained, thanks to the sterling efforts of all members, including the regular cleaning rota (to whom we are most grateful). This ensured a safe and "sanitised" environment and my thanks to everyone who has helped. It is a big job for a small team, not all of whom are regular churchgoers but who still provide support.

As mentioned above, the general condition of St Edward's remains satisfactory albeit there are continual issues with damp/water ingress following any heavy rain. Another wet and damp winter, resulted in expensive but essential repairs to the cradles holding the bells in the Tower costing several thousands of pounds, now resolved. The organ also received attention/servicing, again an essential cost. We are very lucky to continue to benefit from the services of Heather Harvey as church organist and all-round good supporter. Having her playing regularly, especially during Morning Prayer services makes a massive difference to the services and we all thank her sincerely.

The Church has also benefited from a new regular congregational member, Wayne Pearce whose horticultural and general maintenance skills have helped greatly with the continued upkeep of the church grounds in particular.

The underground stream running beneath the tower-side entrance to the church, occasionally produces a waterfall cascading down the front steps at the main entrance to the church following heavy rain, and is obviously very difficult to control, which also results in occasional surface water to the rear of the church and areas in front of the Altar and side chapel, however such ingress has been kept to a minimum. The walls to either side of the altar and the rear wall either side of the stained glass windows have been cleaned and are now awaiting a coat of limewash. The small hole in the roof near to the organ still requires repairing and now the weather is hopefully improving, this will be done as soon as practicable. The population of jackdaws seems to have increased during the year and their nests, particularly adjacent to the drainage downpipes. Keeping the gutters and gullies free from other debris/leaves is an ongoing battle, particularly as much of the guttering is difficult to access without commissioning professional contractors, (which we cannot currently afford). Professional roofing specialists (from "Roofline Fascias") who specialise in church roofing work, and who visited the church just before the original "Lockdown" have again contacted them requesting they revisit as we will undoubtedly have essential repairs to make as part of the Quinquennial Inspection which has been rescheduled for 14 June this year. Financing the requisite work is a cause for concern.

Notwithstanding the successful completion of remedial work to the brackets holding the main bells (mentioned in my last report) at significant cost, the number of times the bells have been rung over the past 15 months or so has been very few which is a great shame. As the PCC is aware, the Captain of the Bells, Ryan Trout, has informed Fthr Simon and others (including me) of his imminent resignation and whilst he has offered his best efforts to find a replacement, we must face up to the fact that there may be a prolonged period where St Edwards and St Mary's are without a regular team, a massive issue especially for St Mary's in terms of being unable to offer the service at weddings. Unfortunately, the impecuniosity of St Edwards has precluded us from being able to move forward on the construction of the planned mezzanine "bell-ringing" floor in the Tower which we remain ever hopeful of completing at some point although this will obviously require serious fund-raising efforts. It should be noted, however, that Ryan and his colleagues have also put in a lot of work clearing and repairing the existing platform in the tower. Ryan has promised me that he will endeavour to find either a replacement captain or, failing that, another team of ringers.

The funding of all such work as well as general operating costs (electricity, insurance, church supplies etc.) as detailed in the Treasurer's Report continues to be a concern, not least the ongoing maintenance of the churchyard. We have very little in the Churchyard Fund. We did, however, again receive £400 from The Parish Council towards the cost of cutting the grass in the Churchyard. The Treasurer will outline the current state of the Churchyard Account in her Report but suffice to say that we will not be in a position to continue employing "Clean-Cut" without additional funds/donations. We have concluded that we MUST organise a number of fund-raising events throughout the rest of the year if we are to continue as a place of worship.

Having missed out on a key fund-raising event in 2022, the Annual Shaugh Prior Duck Race and Barbeque organised by Sue and Peter Burkill largely due to the pandemic, I am optimistic that one will be re-instated in the current year (2023), which provides much needed financial support.

A deserved mention also for Clifton, who has trimmed hedges and provided his gardening services freely, helping to maintain the Churchyard in very good order throughout the year. This external maintenance has only been made possible by the generous donations of several members of the congregation, the continued support of the Parish Council and practical help from several of the congregation, however we are reaching a tipping point.

With regard to ongoing attendance at St Edward's, we have struggled to pay our Common Fund and still owe a proportion of it, albeit a recent  $\pounds 1,000$  payment was made. With the current parlous state of the Church's finances, paying in full is looking a formidable task in the current year. The number of regular churchgoers has continued to fall. As mentioned above, we have a "hardcore" of between 8 and 10 parishioners who attend regularly. We have continued to enjoy the welcome support of Frank as Reader, to help with Morning Prayer services and Fthr Michael Ellis occasionally taking Eucharist Services, and he and his wife Ulla, supporting us regularly as part of the congregation.

We had a couple weddings scheduled at St Edwards during the past year with hopefully another two planned for later in the year (see comments above re bell-ringing). A number of funeral/memorial services were also held throughout the year generating much needed income.

Notwithstanding comments in my last report, I have agreed to put myself forward for re-election at the Annual Meeting. It will be my 9th year as churchwarden and will be my last term. I sincerely hope that, if elected, my final report will reflect an improved financial position, strong and secure church fabric, successful fund-raising activities and a growing congregation.

# Friends of Bickleigh Parish (FoBP) Report

We have been delighted to welcome two new members to our committee this year: Robert Kiver and Karen Griffiths. We are grateful to Robert for contributing his wisdom to the committee, and Karen is proving invaluable for her technological expertise – and was immediately appointed our official Publicity Officer!

At the last count we had 26 Annual and 12 Life members. We have approximately £5 K in our account at present, from which the FoBP paid earlier this year for the repair to the floor at St. Anne's.
